### 4. FIRST AID MEASURES

<b>Inhalation:</b>	Remove victim to fresh air and keep at rest in a position comfortable for breathing. Immediately call a POISON CENTER or doctor/physician.
<b>Skin contact:</b>	Remove/Take off immediately all contaminated clothing. Gently wash with plenty of soap and water. Immediately call a POISON CENTER or doctor/physician.

### 5. FIRE-FIGHTING MEASURES

<b>Suitable extinguishing media:</b>	Dry chemical, foam, carbon dioxide.

<b>Specific hazards arising from the chemical:</b>	Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.

### Precautions for safe handling

Use a ventilation, local exhaust if vapour or aerosol will be generated.
