4. FIRST AID MEASURES

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media:	Dry chemical, foam, carbon dioxide.
Unsuitable extinguishing media:	Water (It may scatter and spread fire.)
Specific hazards arising from the chemical:	Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.
Precautions for firefighters:	Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Technical measures:	Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapour or mist. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated.
Advice on safe handling:	Avoid contact with skin, eyes and clothing.

Storage conditions:	Keep container tightly closed. Store in a cool and dark place. Store locked up. Store away from incompatible materials such as oxidizing agents.
